RESOLUTION NO. 12-156

RESOLUTION APPROVING COST SUBSTANTIATION CERTIFICATE #315 SUBMITTED BY THE OPERATOR OF THE AUTHORITY'S WASTEWATER TREATMENT SYSTEM, APPLIED WATER MANAGEMENT, INC., FOR PAYMENT OF CERTAIN ADDITIONAL EXPENSES RELATED TO THE REPLACEMENT OF THE SEWER JET HOSE DUE TO THE SEWER COLLAPSE AT 57 MOUNTAIN BOULEVARD PURSUANT TO ARTICLE IV OF THE WASTEWATER TREATMENT SYSTEM OPERATION AND MAINTENANCE AGREEMENT

WHEREAS, Applied Water Management, Inc. ("AWM") operates the Authority's Wastewater Treatment System pursuant to the Wastewater Treatment System Operation and Maintenance Agreement between Warren Township Sewerage Authority and AWM, dated June 1, 2009 (the "Agreement"); and

WHEREAS, the Agreement provides that AWM submit a Cost Substantiation Certificate ("CSC") for any cost reasonably incurred or to be incurred by AWM which is chargeable in whole or in part to the Authority; and

WHEREAS, Article IV, Section 4.8 of the Agreement provides that AWM shall be responsible for the cost of Routine Maintenance and Preventive Maintenance of the Wastewater Treatment System, but that the Authority shall be responsible for the costs associated with repairs, replacements, and non-Routine Maintenance provided that AWM follows the Cost Substantiation procedures set forth in the Agreement; and

WHEREAS, a sewer collapse at 57 Mountain Boulevard resulted from the relocation of Verizon Telephone Pole No. 1605, which is an item of repair, replacement, or non-Routine Maintenance pursuant to Article IV and Appendix 16 of the Agreement; and

WHEREAS, the Authority has signed Resolution 12 – 151 in the amount of \$3,869.75 for costs related to the labor for the repair of the sewer collapse, and such amount included a \$1,000 charge for certain equipment costs; and

WHEREAS, AWM has submitted CSC #315 representing additional costs for parts and shipping related to the replacement of the sewer jet hose due to damage from the sewer collapse at 57 Mountain Boulevard; and

WHEREAS, these items of work are not included on the pre-approved list submitted by AWM for this Contract Year, but the Authority agrees that this additional work is a necessary item of repair, replacement, or non-Routine Maintenance; and

WHEREAS, payment to AWM shall be from the Authority's Operating Account;
and

WHEREAS, the Authority has reviewed CSC #315, dated January 9, 2013, in the amount of \$177.98, and is satisfied that the amount is fair and reasonable, and that the Authority desires to approve CSC #315; and

NOW, THEREFORE, BE IT RESOLVED, by the Warren Township Sewerage Authority in the County of Somerset, New Jersey that:

1. CSC #315, signed in the amount of \$177.98, for payment of additional costs for parts and shipping related to the replacement of the sewer jet hose due to damage from the sewer collapse at 57 Mountain Boulevard, be and hereby is approved.

2. Payment to AWM shall be from the Authority's Operating Account after receipt of a business registration certificate from AWM for every subcontractor that performed work on the project, unless such certificate is already on file with the Authority.
