RESOLUTION NO. 12-17

**RESOLUTION AUTHORIZING REFUNDS FOR THE DEPOSIT
OF CONNECTION FEES AND STUB FEES**

WHEREAS, under the unique circumstances associated with the sewer extension proposed by Jose Domingues (the "Domingues Line"), and approved by the Authority by Resolutions 09-105 and 09-125, the Authority determined to allow the property owners on Old Stirling Road whose property was within 200 feet of the proposed Domingues Line to "lock in" the \$2,200 stub reimbursement fee if that fee was paid before the Authority increased the amount of that fee to \$5,000. The Authority also agreed to allow those impacted property owners to "lock in" the 2009 connection fee in the amount of \$6,996, if that connection fee was paid before the Authority increased it for 2010; and

WHEREAS, four property owners paid the \$2,200 stub reimbursement fee and the 2009 connection fee in the amount of \$6,996, for a total deposit of \$9,196 each; and

WHEREAS, under the Authority's Rules and Regulations, the connection fee need not be paid until actual application to connect to the sewer system. Additionally, Mr. Domingues advised the Authority that he does not intend to proceed with construction of the sewer line, and thus, the Authority will authorize refunds of the deposits for the connection and stub fees as set forth herein; and

WHEREAS, the Authority, by Resolution No. 10-98, previously refunded to Fred and Rosalie Gauch of 67 Stirling Road the \$6,996 connection fee deposit and also refunded the \$2,200 stub fee in August of 2011 as reflected in the applicable bill list resolution; and

WHEREAS, the Authority hereby authorizes a refund to Mr. and Mrs. Andrew Peluso of 65 Old Stirling Road of the deposit for the connection fee in the amount of \$6,996 and for the stub reimbursement fee of \$2,200, for a total refund of \$9,196; and

WHEREAS, the Authority hereby authorizes a refund to Mr. and Mrs. Hank Klumpp of 63 Old Stirling Road of the deposit for the connection fee in the amount of \$6,996 and for the stub reimbursement fee of \$2,200, for a total refund of \$9,196; and

WHEREAS, the Authority hereby authorizes a refund to Flamingo Builders of the deposit for the connection fee in the amount of \$6,996 and for the stub reimbursement fee of \$2,200, for a total refund of \$9,196.

NOW, THEREFORE, BE IT RESOLVED by the members of the Warren Township Sewerage Authority, County of Somerset, State of New Jersey as follows:


