**RESOLUTION NO. 13-89**

**RESOLUTION APPROVING COST SUBSTANTIATION  
CERTIFICATE #347 SUBMITTED BY THE OPERATOR  
OF THE AUTHORITY'S WASTEWATER TREATMENT  
SYSTEM, APPLIED WATER MANAGEMENT, INC., FOR  
PAYMENT OF CERTAIN EXPENSES RELATED TO THE  
DISPOSAL OF SLUDGE PURSUANT TO ARTICLE IV OF  
THE WASTEWATER TREATMENT SYSTEM  
OPERATION AND MAINTENANCE AGREEMENT**

**WHEREAS**, Applied Water Management, Inc. ("AWM") operates the Authority's Wastewater Treatment System pursuant to the Wastewater Treatment System Operation and Maintenance Agreement between Warren Township Sewerage Authority and AWM, commencing June 1, 2009 (the "Agreement"); and

**WHEREAS**, the Agreement provides that AWM submit a Cost Substantiation Certificate ("CSC") for any cost reasonably incurred or to be incurred by AWM which is chargeable in whole or in part to the Authority; and

**WHEREAS**, Article IV, Section 4.8 of the Agreement provides that AWM shall be responsible for the cost of Routine Maintenance and Preventive Maintenance of the Wastewater Treatment System, but that the Authority shall be responsible for the costs associated with repairs, replacements, and non-Routine Maintenance provided that AWM follows the Cost Substantiation procedures set forth in the Agreement; and

**WHEREAS**, a malfunction of the sludge thickener VFD due to the improper electrical grounding of Stage V resulted in sludge from all three treatment plants having to be hauled directly to PVSA for disposal, which is an item of repair, replacement, or non-Routine Maintenance pursuant to Article IV and Appendix 16 of the Agreement; and

**WHEREAS**, AWM has submitted six invoices from Russell Reid, each for a total of \$2,509.50, which AWM has discounted for the costs of normal sludge transport and polymer usage, for a total of \$7,669.20; and

**WHEREAS**, AWM has submitted CSC #347 for the costs of additional sludge disposal, the above-referenced invoices and the applicable ten (10%) percent markup of \$766.92 applied on said invoice for a total cost of \$8,436.12 to the Authority; and

**WHEREAS**, this item of work is not included on the pre-approved list submitted by AWM for this Contract Year, but the Authority agrees that this additional work is a necessary item of repair, replacement, or non-Routine Maintenance; and

**WHEREAS**, payment to AWM shall be from the Authority's Operating Account; and

**WHEREAS**, the Authority has reviewed CSC #347, dated July 11, 2013 in the amount of \$8,436.12, and is satisfied that the amount is fair and reasonable, and that the Authority desires to approve CSC #347.

**NOW, THEREFORE, BE IT RESOLVED**, by the Warren Township Sewerage Authority in the County of Somerset, New Jersey that:

1. CSC #347, signed in the amount of \$8,436.12, for the costs associated with the disposal of additional sludge, be and hereby is approved, conditioned upon receipt of a business registration certificate from AWM for every subcontractor that performed work on the project, unless such certificate is already on file with the Authority.

2. Payment to AWM shall be from the Authority's Operating Account.
