RESOLUTION NO. 14-46

RESOLUTION GRANTING FINAL APPROVAL FOR THE APPLICATION OF ANTHONY AND ROSALIE CIUFO FOR CONNECTION BY MEANS OF A 4-INCH GRAVITY LATERAL LINE AND SADDLE TAP WITH ONE (1) EDU OF CAPACITY TO SERVE AN EXISTING SINGLE-FAMILY DWELLING LOCATED AT 19 NORTH LANE, BLOCK 72, LOT 4, IN THE STAGE IV SEWER SERVICE AREA

WHEREAS, the applicant, Anthony and Rosalie Ciufu, has applied to the Authority for approval for connection by means of a 4-inch gravity lateral with one (1) EDU of capacity to serve an existing single-family dwelling on Block 72, Lot 4, in the Stage IV sewer area; and

WHEREAS, by way of Resolution No. 12-124, the Authority granted conditional preliminary approval of the application, with the grant of final approval upon the satisfaction of various conditions; and

WHEREAS, one of these conditions was a requirement that the applicant obtain from the NJDEP revision of the WQMP to allow sewerage of the property into the Stage IV treatment plant, and no connection was to be made until evidence of approval of such revision was obtained; and

WHEREAS, Resolution No. 12-124 also provided that the Authority's administrator was authorized to sign off on such final approval, which would be memorialized by the full Authority at the next meeting; and

WHEREAS, the applicant has provided evidence of such approval satisfactory to the Authority, the Authority administrator has authorized final approval, and the Authority now desires to memorialize such approval.

NOW, THEREFORE, BE IT RESOLVED, by the Warren Township Sewerage Authority in the County of Somerset, New Jersey that the Authority hereby grants final approval to Anthony and Rosalie Ciufu for connection by means of a 4-inch gravity lateral with one (1) EDU of capacity to serve an existing single-family dwelling on Block 72, Lot 4 located at 19 North Lane, in the Stage IV sewer service area; and


BE IT FURTHER RESOLVED, that all other conditions of Resolution No. 12-124 remain in full effect.
