**RESOLUTION NO. 14-56**

**RESOLUTION APPROVING COST SUBSTANTIATION CERTIFICATE #378A SUBMITTED BY THE OPERATOR OF THE AUTHORITY'S WASTEWATER TREATMENT SYSTEM, APPLIED WATER MANAGEMENT, INC., FOR PAYMENT OF CERTAIN EXPENSES RELATED TO STAGE V THICKENED SLUDGE TANK LEVEL SENSOR CONTROLS REPLACEMENT PURSUANT TO ARTICLE IV OF THE WASTEWATER TREATMENT SYSTEM OPERATION AND MAINTENANCE AGREEMENT**

**WHEREAS**, Applied Water Management, Inc. ("AWM") operates the Authority's Wastewater Treatment System pursuant to the Wastewater Treatment System Operation and Maintenance Agreement between Warren Township Sewerage Authority and AWM, commencing June 1, 2009 (the "Agreement"); and

**WHEREAS**, the Agreement provides that AWM submit a Cost Substantiation Certificate ("CSC") for any cost reasonably incurred or to be incurred by AWM which is chargeable in whole or in part to the Authority; and

**WHEREAS**, Article IV, Section 4.8 of the Agreement provides that AWM shall be responsible for the cost of Routine Maintenance and Preventive Maintenance of the Wastewater Treatment System, but that the Authority shall be responsible for the costs associated with repairs, replacements, and non-Routine Maintenance provided that AWM follows the Cost Substantiation procedures set forth in the Agreement; and

**WHEREAS**, it was necessary to replace the Stage V thickened sludge tank level sensor controls, which is an item of repair, replacement, or non-Routine Maintenance pursuant to Article IV and Appendix 16 of the Agreement; and

**WHEREAS**, AWM has submitted an invoice from Precision Digital for \$404.00, and the applicable AWM mark up of \$40.40 for a total of \$444.40; and

**WHEREAS**, AWM has submitted CSC #378A for the replacement of the Stage V thickened sludge tank level sensor controls, the above-referenced invoice and the applicable ten (10%) percent markup on said invoices for a total cost of \$444.40 to the Authority; and

**WHEREAS**, this item of work is not included on the pre-approved list submitted by AWM for this Contract Year, but the Authority agrees that this additional work is a necessary item of repair, replacement, or non-Routine Maintenance; and

**WHEREAS**, payment to AWM shall be from the Authority's Operating Account; and

**WHEREAS**, the Authority by way of Resolution No. 14-31 previously approved \$4,424.94, respectively, for costs associated with the Stage V thickened sludge tank level sensor controls; and

**WHEREAS**, the Authority has reviewed CSC #378A, dated May 28, 2014 in the amount of \$444.40, and is satisfied that the amount is fair and reasonable, and that the Authority desires to approve CSC #378A.

**NOW, THEREFORE, BE IT RESOLVED**, by the Warren Township Sewerage Authority in the County of Somerset, New Jersey that:

1. CSC #378A, signed in the amount of \$444.40, for the costs associated with the Stage V thickened sludge tank level sensor controls replacement, be and hereby is approved, conditioned upon receipt of a business registration certificate from AWM for every subcontractor that performed work on the project, unless such certificate is already on file with the Authority.

2. Payment to AWM shall be from the Authority's Operating Account.
