RESOLUTION NO. 14-61

RESOLUTION RETROACTIVELY ACCEPTING AN INCREASE IN THE HOURLY RATE FOR CARROLL OLIVA, A SENIOR ENGINEER AT PS&S, DUE TO A TYPOGRAPHICAL ERROR IN THE PREVIOUS RATE SHEET

WHEREAS, by Resolution 14-04 the Authority awarded PS&S an Engineering Contract by which PS&S agreed to serve as the Authority Engineer, effective February 1, 2014; and

WHEREAS, the Engineering Contract includes a rate sheet provided by PS&S whereby the hourly rates for each of the engineers and other professionals are recorded; and

WHEREAS, Carrol J. Oliva, PE, RA, Oliva currently holds Engineering Licenses in New Jersey, New York, Pennsylvania, Ohio, Illinois, and Florida, previously held Engineering Licenses in Connecticut and West Virginia; is currently licensed as a Registered Architect in New Jersey, and is currently licensed as a C-4 and S-4 in New Jersey. He is a Life Member of AWWA, 49 years; a Life Member of ASCE, 46 years, and a Life Member of WEF, 35 years; and

WHEREAS, Mr. Oliva recently returned to PS&S, after working on several other projects, as a senior director of design, and was given the lead engineering design role for the WTSA construction projects known as Contracts 52, 54 and 55; and

WHEREAS, the original rate sheet included in the February 2014 Contract misstated the hourly rate for Mr. Oliva; and

WHEREAS, the proper hourly rate for Mr. Oliva is \$170, which the Authority acknowledges is appropriate given his education and experience; and

WHEREAS, PS&S has provided a revised rate sheet that reflects this adjustment.


NOW, THEREFORE, BE IT RESOLVED, by the Warren Township Sewerage Authority in the County of Somerset, New Jersey that the revised rate sheet including the increased rate for Mr. Carrol J. Oliva is hereby retroactively adopted by the Authority, effective February 1, 2014.
